Clause 1 – Definitions

For the purposes of this Agreement, the following terms shall have the meanings ascribed to them herein unless the context otherwise requires.

Clause 2 – Grant of License

Designer hereby grants to Client a non-exclusive, non-transferable license to use the Alphabet Letter Design solely for the purposes and mediums agreed upon herein.

Clause 3 – Ownership

All ownership rights, including copyrights and intellectual property rights, in the Alphabet Letter Design remain with Designer. Client acknowledges no ownership rights except the license granted herein.

Clause 4 – Delivery

Designer shall deliver the final design files in the agreed format to Client within a reasonable timeframe after execution of this Agreement and receipt of any required payments.

Clause 5 – Payment

Client agrees to pay the License Fee as specified in this Agreement. Payment shall be made via the agreed method prior to or upon delivery of the design files.

Clause 6 – Use Restrictions

Client shall not reproduce, adapt, modify, or sublicense the Alphabet Letter Design beyond the scope of the granted

license without prior written consent of Designer.

Clause 7 – Warranties and Representations

Designer represents that the Alphabet Letter Design is original, does not infringe upon any third party rights, and Client's use pursuant to this Agreement will not infringe on any third party rights.

Clause 8 – Indemnification

Client agrees to indemnify and hold Designer harmless from any claims, damages, losses, or expenses arising out of Client's unauthorized use or misuse of the Alphabet Letter Design.

Clause 9 – Term and Termination

This Agreement shall commence upon execution and continue until terminated by either party upon written notice. Termination shall not affect accrued rights or obligations.

Clause 10 – Confidentiality

Both parties agree to keep confidential all non-public information disclosed in connection with this Agreement and use such information solely for purposes of performing hereunder.

Clause 11 – Limitation of Liability

To the maximum extent permitted by law, Designer's liability under this Agreement shall be limited to the License Fee paid by Client. In no event shall Designer be liable for consequential or incidental damages.

Clause 12 – Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of the State of _____. The parties consent to the exclusive jurisdiction of the state and federal courts located in _____ County, _____.

Clause 13 – Entire Agreement

This Agreement constitutes the entire understanding between the parties regarding the subject matter herein and supersedes all prior negotiations or agreements.

Clause 14 – Amendments

Any amendments or modifications to this Agreement must be in writing and signed by both parties to be effective.

Clause 15 – Severability

If any provision of this Agreement is deemed invalid or unenforceable, the remainder shall remain in full force and effect.

Clause 16 – Waiver

Failure to enforce any provision of this Agreement shall not be deemed a waiver of future enforcement of that or any other provision.

Clause 17 – Notices

All notices under this Agreement shall be in writing and delivered by hand, certified mail, overnight courier, or electronic means with delivery confirmation.

Clause 18 – Assignment

Neither party may assign or transfer their rights or obligations under this Agreement without prior written consent of the other party.

Clause 19 – Force Majeure

Neither party shall be liable for delays or failures to perform due to causes beyond their reasonable control, including but not limited to natural disasters, acts of government, or labor disputes.

Clause 20 – Signatures

This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which together constitute one and the same instrument.
