Statement of Intent:

Any disputes arising out of or relating to this Letter shall be subject to the exclusive jurisdiction of the federal or state courts located within the United States.

Non-Binding Agreement:

This Letter is not intended to create any legally binding obligation to marry or to perform any other act, nor does it restrict either party from terminating the intention to marry at any time prior to the solemnization.

Miscellaneous:

This Letter contains the entire understanding between the parties regarding the subject matter herein and supersedes any prior communications or agreements, whether oral or written. Any amendments or modifications must be in writing and signed by both parties. If any provision of this Letter is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.
