

PIRATE LETTER OF DEMAND

To Whom It May Concern:

This letter serves as a formal demand for the immediate return and restitution of the vessel and all goods wrongfully taken, detained, or withheld by the undersigned Party (hereinafter referred to as “the Pirate”) from the rightful owner or claimant (hereinafter referred to as “the Owner”). The Owner asserts full legal and equitable title to the vessel and all associated property identified herein, and hereby demands compliance with applicable United States maritime and property laws.

1. Identification of the Vessel and Property:

The vessel subject to this demand is described as follows: Make/Model: _____, Year of Manufacture: _____, Length Overall (LOA): _____, Registration Number or HIN: _____. All onboard equipment, accessories, cargo, and appurtenances presently in the possession of the Pirate are included herein.

2. Demand for Immediate Return:

The Owner demands the immediate and unconditional return of the vessel and all associated property, free from any liens, claims, or encumbrances. Failure to comply with this demand will result in legal action pursuant to United States federal and state laws governing maritime theft, conversion, and recovery of property.

3. Legal Authority and Applicable Law:

This demand is made under the authority of applicable United States laws including but not limited to the Maritime Lien Act, the National Stolen Property Act, and relevant state statutes governing property rights and remedies. The Owner reserves all rights to pursue civil and criminal remedies, including but not limited to recovery, damages, and attorney’s fees.

4. Notice of Intent:

Unless the vessel and all associated property are returned within fourteen (14) calendar days from receipt of this Letter, the Owner intends to initiate legal proceedings without further notice. This Letter shall serve as evidence of the Owner’s good faith efforts to resolve this matter amicably before pursuing judicial relief.

6. Reservation of Rights:

The Owner expressly reserves all rights, claims, and remedies available under law and equity, including without

limitation the right to seek injunctive relief, damages, costs, and attorneys' fees, and no provision of this Letter shall be construed as a waiver of any such rights.

By receipt of this Letter, the Pirate acknowledges the Owner's lawful claim to the vessel and associated property and agrees to comply fully with the demands herein to avoid further legal action.
