Subject:

Cease and Desist Demand Regarding Unlawful Robocalls

This letter serves as a formal demand for you to immediately cease and desist all unauthorized robocalls to the recipient's telephone number(s) in violation of the Telephone Consumer Protection Act (TCPA), 47 U.S.C. § 227, and any applicable state laws. You are hereby notified that such calls are unlawful and actionable. Failure to comply will result in legal actions to enforce the recipient's rights.

1. Unauthorized Robocalls Prohibited

You are prohibited from making any robocalls to the recipient's telephone number(s) without prior express written consent as required by the TCPA. This includes any prerecorded voice messages, automated dialing systems, or artificial/prerecorded voice transmissions.

2. Legal Basis for Demand

The TCPA imposes strict requirements and provides for statutory damages of \$500 per violation, which may be increased to \$1,500 per willful or knowing violation. State laws may provide for additional remedies, including injunctive relief and attorney's fees.

3. Cease and Desist Requirement

You must immediately cease all robocalling activities to the recipient's telephone number(s). Any further calls will be considered a willful violation subject to statutory penalties and injunctive relief.

4. Preservation of Evidence

You are required to preserve all records, call logs, consent forms, recordings, scripts, and any other documents or electronic data related to calls made to the recipient, including but not limited to those made by third parties or affiliates.

5. Demand for Written Assurance

You must provide written assurance within seven (7) days from receipt of this letter confirming that all unauthorized robocalls have ceased and that you will not engage in such conduct in the future.

6. Reservation of Rights

The recipient reserves all rights to pursue all available legal remedies, including filing complaints with the Federal Communications Commission (FCC), Federal Trade Commission (FTC), state attorneys general, and initiating private litigation.

7. Governing Law and Venue

This demand letter and any dispute arising hereunder shall be governed by and construed in accordance with the laws of

the United States, including federal statutes such as the TCPA, and applicable state laws without regard to conflict of laws principles.

8. No Waiver

Nothing contained in this letter shall be construed as a waiver of any rights or remedies available to the recipient under applicable law, all of which are expressly reserved.

9. Contact for Compliance

All communications regarding compliance with this demand must be directed to the undersigned at the address or contact information provided above.
