Warranty Terms and Conditions:

1. Warranty Coverage

The Warranty Provider warrants that the product or service described above shall be free from defects in material and workmanship under normal use and service for the duration of the warranty period. The specific warranty period shall be as stated in the attached schedule or invoice.

2. Remedies

If a defect covered by this Warranty arises and a valid claim is received within the warranty period, the Warranty Provider will, at its sole discretion, either (a) repair the product using new or refurbished parts, (b) replace the product, or (c) refund the purchase price. All repairs or replacements will be provided at no charge to the Warranty Recipient.

3. Warranty Exclusions

This Warranty does not cover damages or defects caused by misuse, abuse, neglect, alteration, unauthorized repair, accident, normal wear and tear, improper maintenance, or failure to follow instructions. Consumable parts such as batteries, bulbs, and fuses are excluded unless otherwise specified.

4. Claim Procedure

To obtain warranty service, the Warranty Recipient must provide written notice to the Warranty Provider describing the defect in reasonable detail and may be required to return the product or provide access to the affected service. The Warranty Provider reserves the right to inspect and test the product before honoring a claim.

5. Limitation of Liability

The Warranty Provider's liability under this Warranty is limited to the remedies expressly provided herein and does not extend to any incidental or consequential damages, including but not limited to loss of use, loss of profits, or property damage.

6. Transferability

This Warranty is transferable to subsequent owners of the product during the warranty period provided that the Warranty Provider is notified in writing within thirty (30) days of transfer and the new owner agrees to these terms.

7. Governing Law

This Warranty shall be governed by and construed in accordance with the laws of the United States and the State where the Warranty Provider is located, without regard to conflict of law principles.

8. Severability

If any provision of this Warranty is held to be invalid or unenforceable, such provision shall be severed and the remaining provisions shall remain in full force and effect.

9. Entire Agreement

This Warranty constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements or understandings, whether written or oral.

10. Amendments

No amendment to this Warranty shall be effective unless made in writing and signed by both parties.

11. Waiver

No waiver of any breach of this Warranty shall be deemed a waiver of any subsequent breach.

12. Notices

All notices required or permitted under this Warranty shall be in writing and delivered personally, sent by certified mail, return receipt requested, or by nationally recognized overnight courier service to the addresses set forth above or as updated by written notice.

13. Dispute Resolution

Any disputes arising under or relating to this Warranty shall be resolved first by good faith negotiations between the parties. If unresolved, disputes shall be subject to binding arbitration in accordance with the rules of the American Arbitration Association, held in the Warranty Provider's state.

14. No Other Warranties

Except as expressly stated herein, the product is provided 'AS IS' and the Warranty Provider disclaims any and all other warranties, express or implied, including but not limited to implied warranties of merchantability and fitness for a particular purpose.

15. Force Majeure

The Warranty Provider shall not be liable for any failure or delay in performance due to causes beyond its reasonable control, including but not limited to acts of God, war, terrorism, embargoes, government orders, natural disasters, or labor disputes.

16. Signature and Acceptance
