

LAST WILL AND TESTAMENT

ARTICLE I. DECLARATIONS

If any beneficiary under this Will contests this Will or any of its provisions, any share or interest in my estate given to

that contesting beneficiary is revoked and shall be disposed of as if that contesting beneficiary predeceased me.

ARTICLE VII. OMISSION

I have intentionally omitted to provide for any heirs not specifically named in this Will.

ARTICLE VIII. TAXES

I direct that all estate, inheritance, transfer, and succession taxes payable by reason of my death shall be paid out of my residuary estate.

ARTICLE IX. GOVERNING LAW

This Will shall be governed by and construed under the laws of the State of _____, United States of America.

ARTICLE X. REVOCATION OF PRIOR WILLS
